The Love Without Agenda Extended Partnership program is perfect for people who have a need to take donations and desire the benefits of legal structure—but don't want to go thru the long and expensive process of setting up a legally independent 501c3. This empowers people in the neighborhoods who already know what is needed and are willing to act—and allows them to focus their time and resources most effectively.

How does this legally work? Love Without Agenda has a registered 501c3 Group Status. This allows us to legally extend our non profit status over qualified community work. These chapters (Extended Partners) are legal & independent businesses who receive it's non profit status thru Love Without Agenda

We think it is a perfect fit for local and long term projects that start small but have the potential to grow larger. Things such as annual coat drives, community houses, food pantries, start-ups, and part-time but long-term projects are some of the great projects that fit well. Our goal is to incubate thousands of leaders doing important work across the globe—receiving what they need to grow and replicate. We believe many of them will eventually become independent 501c3's.

Extended Partnerships are perfect for short term and long term many reasons:

Requirements & Qualifications:

- File for doing business in your state and open bank account under that name.
- Pay 1 time set up fee to IRS & LWA of \$200
- Pay \$25 monthly LWA for support & annual accounting services
- Must perform qualified 'community service' as defined by the IRS & LWA. (this is very broad)
